**DEPOSIT AND FINAL PAYMENT:** A Deposit of \$200.00 (for 48 or less) OR \$400.00 (for more than 48 players) will be required within 10 DAYS of receipt of our outing contract to hold your date. Additionally, the contract must be signed and returned with your deposit. The balance is due on the day of the event. A refund of your deposit will only be made if: 1) you cancel a minimum of 45 days prior to the tournament date. 2) Due to inclement weather, Country View officially closes the course and a mutually satisfactory rain date cannot be selected.

**GUARANTEE:** Outings must provide a tournament count at least 10 days prior to the event. The undersigned agrees to pay for the guaranteed number of players contracted, which includes greens fees, carts, and food.(NO REFUNDS FOR NO SHOWS)

**ALCOHOLIC BEVERAGES/ FOOD: All food & beverages must be purchased and consumed on the premises (NO COOLERS WILL BE TOLERATED). This will be a zero tolerance policy.**

**ADDITIONAL POLICIES:**

- 1) Country View Golf Club is a spikeless golf course please advise all golfers. If needed soft spikes can be purchased at the course, but advise players to arrive early to respike their shoes.
- 2) Country View Golf Club reserves the right to inspect and control all private functions. Liability for any damage to the premises will be charged accordingly to the group and/or coordinator.
- 3) Country View Golf Club cannot assume responsibility for personal property and equipment brought onto the premises.
- 4) The person in charge or the company undersigned is responsible for any damages occurring on the above date to carts rented to the above group. It is agreed that in signing this contract for golf cart rentals, the undersigned agrees to:
  - A. Assume all risks attendant with operation and use thereof including responsibility for any damage caused to said cart due to negligent use of operation of the same.
  - B. Release Country View Golf Club from any liability from injury to his person or property resulting from said operation.
  - C. Not allow children under 18 years old to operate carts.
  - D. Not to drive golf carts outside of golf course property or in restricted areas of the course.
